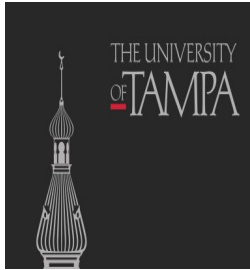

# Academic Program Development

## Computer Science

The B.S. program in Computer Science launched in the fall 2021 semester with approximately 26 majors. Moving into its second year, we anticipate the new class of incoming freshmen in fall 2022 should bring the total of majors to 65-70.

## Data Science

The new B.S. program in Data Science was approved by the Faculty Senate and will recruit its first class in fall 2022. Dr. Binod Rimal was recruited as the first data science faculty member in the college. Similar to the launch of the actuarial science program, we anticipate a very small class in 2022, due to the lateness of all the approvals. Also similar to actuarial science, we expect the recruitment of majors to increase steadily over the next few years.

## Mathematics with Computer Science

The revised curriculum for B.S. degree program in Mathematics with Computer Science was successfully launched in Fall 2021.

## Educational Leadership

The M.Ed. in Educational Leadership team formed a partnership with Pasco County Schools in 2020-21 and this partnership has now extended to Hillsborough County Schools. As a result, we anticipate larger enrollments in EDL classes going forward. However, many of these students will be non-degree seeking students who already have earned a M.Ed. (not in EDL); and are seeking to earn FELE certification.

## Instructional Design and Technology

The Instructional Design and Technology Program's Online Development Graduate Certificate has been approved by the Faculty Senate. Students who enroll in this graduate certificate program intend to pursue careers as experts in the design, development, implementation, and evaluation of online learning experiences to train, educate, and improve performance in multiple environments. The certificate will be implemented fall 2022.

## Education Minor

The Professional Education Minor launched in fall 2021 and received certification from the Florida Department of Education. The program now has 23 students enrolled in the Professional Education Minor and appears to be gaining traction.

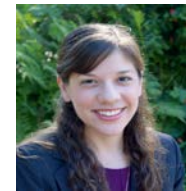

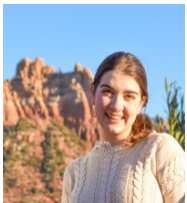

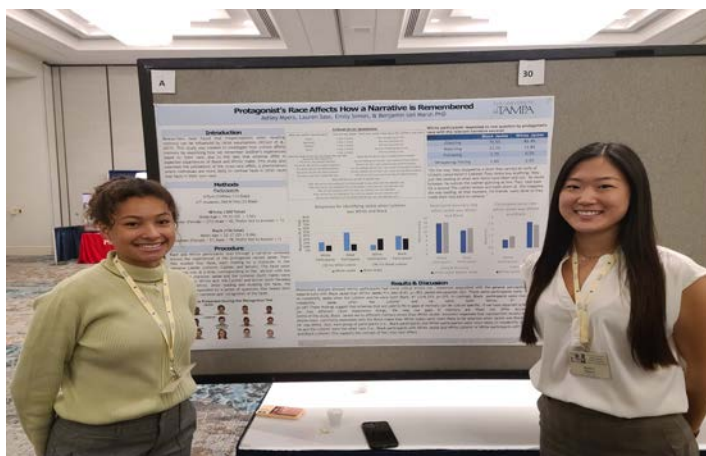
